How to give Omalizumab subcutaneous injection via self-administration at home

This information is to help you or your carer learn how to safely give your medication by a subcutaneous injection.

What is a subcutaneous injection?

A subcutaneous injection is an injection given under your skin into fatty tissue.


Your injection will come in a pre-filled syringe and depending on the dose prescribed to you by your doctor, you may need to use one or more pre-filled syringes and inject the contents of all of them.

Choose an injection site (area on your body)

You should be able to pinch your skin into a fold to raise the fatty tissue.

Avoid areas of skin at are red, inflamed, hard, bruised, have scars, birthmarks or stretch marks.

Preparing for your subcutaneous injection

This ideally should be done in a quiet place, away from distractions.

Clean a flat surface to put your supplies onto and gather your supplies:

- 1 x alcohol swab.
- 1 x gauze pad / cotton ball.
- 1 x sharps bin.
- 1 x pre-filled syringe or vials/needle/ syringe.

Check the medication/packaging:

- Name
- Dose
- Expiry.

This should be completed for every injection/vial.

If the medication details are in correct, **do not use** the medication and inform the Medical Day Case Unit. Now you need to:

- Wash your hands with soap and water and or alcohol-based hand sanitizer.
- Fold back/remove any clothing covering the chosen injection site.

Using a pre-refilled syringe (Omalizumab)

- Open the alcohol swab, using a side to side, up and down motion (similar to a #). Clean the skin at the chosen injection site and allow to dry for 30 seconds without touching the cleaned area.
- 2. Pick up the pre-filled syringe with your dominant hand (the hand your write with or use the most) carefully pull to needle cover off.

Do not let anything, including your fingers, touch the needle - this is sterile and very sharp.

If this happens put the pre-filled syringe into the sharps bin and call the medical day case unit for advice.

- 3. Hold the syringe around the middle with your fingers (like a pen) with your dominant hand.
- 4. Pinch your skin to raise a fold between your fingers (with your non-dominant hand).
- 5. Push the needle straight down into your skin (at a 90 degree angle) in one smooth, quick motion.
- 6. Using your thumb, slowly push the plunger all the way until it won't go any further.

- Remove your thumb from the plunger, stop pinching your skin, and gently remove the needle from your skin.
- 8. Place the used pre-filled syringe in the sharps bin provided.
- 9. Have a small piece of gauze or cotton pad available to place over the injection site in case of any bleeding and apply gentle pressure (do not rub the injection site as this can cause irritation).

Reaction to medications

Please read the leaflet provided with your medication.

Reactions usually occur during the first few doses.

If you experience swelling, tightness of the throat, chest pain, severe dizziness, fainting, collapse, worsening breathlessness or wheeze, then you must **attend your nearest accident and emergency department or call 999.**
