Rheumatology – Shared Care

'Shared Care' is the prescribing and monitoring of disease-modifying anti-rheumatic drug (DMARD) therapy, where responsibility for your care is shared between your rheumatology consultant and your GP.

You have **not** been discharged from the rheumatology department, and you will still attend the rheumatology clinic for review of your rheumatic condition.

In order to initiate Shared Care:

- Please make an appointment to see your GP practice nurse to arrange regular monitoring of your DMARD therapy.
- You should be monitored every weeks.
- Your first monitoring appointment at your GP surgery should be on

Once Shared Care is in place:

- Your medication will be prescribed by your GP.
- Blood monitoring and blood pressure checks (if required) will be done at your GP surgery.

Your DMARD(s) dose schedule and frequency of monitoring will always be documented in your copy of the rheumatology clinic letter.

We ask you to:

- Ensure you make appointments and attend for regular monitoring at your GP surgery.
- Comply with the prescribed monitoring schedule.
- Ensure your monitoring booklet (Methotrexate/DMARD) is completed with up-to-date blood results. Please bring the monitoring booklet to your rheumatology clinic appointment.
- Contact your GP or the Rheumatology Advice Line (number below) if you feel unwell.
- Limit alcohol consumption to a minimum and avoid completely if taking Leflunomide.
- If you are planning a pregnancy, **please discuss** with your rheumatology team a few months **in advance**.
- Attend for your review as planned in the rheumatology clinic. If you are unable to attend, please ring the Appointments Office on 01623 622515, extension 4112, to cancel and rebook a new appointment.
