With reference to your request for information received on 2<sup>nd</sup> August 2023, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information you have requested. - 5. Responsible Person for the Contract:**
  - The name and contact information (including email and phone number) of the individual responsible for overseeing the fire damper maintenance contract across the trust.
- 6. Contract Renewal Date:**
  - The date on which the current fire damper maintenance contract is due for renewal.
