## **Executive Summary**

The paper describes the policy context and rationale for the establishment of an ICS Board to oversee health and social care system transformation in Nottingham and Nottinghamshire. As one of the fourteen nationally designated ICS accelerator sites, Nottingham and Nottinghamshire is expected to put robust governance arrangements in place to supersede the current STP oversight arrangements and in so doing strengthen organisational buy-in and democratic accountability for the scale of system transformation that is envisaged.
