With reference to your request for information received on 8<sup>th</sup> February 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

**We kindly are requesting information on your institution's post-mortem procedures related to patients with cardiac devices. We have attached a short questionnaire in line with the above-mentioned objectives.**

We do not perform post-mortems here at Sherwood Forest Hospitals, routinely we send patients to Nottingham University Hospital.
