The Trust operates a PSL (8 agencies) for agency nursing staff with the Trust setting the rates that are paid. Supplier performance is monitored and a Suppliers failure to provide adequate volume (at the pre-agreed rates) would result in that supplier's removal from the PSL. Only when a Suppler is removed from the PSL would the Trust seek to add additional Suppliers to the PSL.
