With reference to your request for information received on 23rd April 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do not hold the information you have requested. Please accept our sincere apologies for the delay.

In your request you asked:

- 1. Does the trust work with translation services that translate healthcare information communications, e.g. leaflets, letters, posters etc?
 - For 2023/24 the translation contract was with The Big Word.
- 2. How many healthcare information leaflets/communications did the trust produce and print in **FYE 2024?**

In 2023, there were x8 translations completed. These included information for specific patients and generic leaflets.

- 3. How many of these were translated in multiple languages? Only 1 request was for multiple languages. Requests are usually to translate into 1 specific language.
- 4. Which languages does the trust normally translate healthcare information communications

The languages translated in 2023 were: - English, Turkish, Polish, Romanian, Bengali, Lithuanian, Latvian, Albania.

5. How are healthcare information communications delivered to patients that are visually impaired?

Letters and Communications are provided in Larger and Bolder Font.

- 6. What did the trust spend on translation services for healthcare communications in FYE 2024?
 - This was approximately £620.00.
- 7. What did the trust spend on printing of healthcare communications in FYE 2024? Information is not held in a format to identify specifically spend on printing.
- 8. Please provide the name of the person responsible for managing the creation of healthcare information communications?

Names, job titles and email addresses (other than that of our board of directors) constitute personal data.

Section 40(2) provides that personal data is exempt information if one of the conditions set out in section 40(3) is satisfied. In our view, disclosure of this information would breach the data protection principles contained in the General Data Protection Regulations and Data Protection Act 2018.

In reaching this decision, we have particularly considered:

- The reasonable expectations of the employees given their positions; Sherwood Forest Hospitals NHS Foundation Trust considered that none of the individuals would have a reasonable expectation that their personal data would be disclosed;
- The consequences of disclosure; and
- · any legitimate public interest in disclosure.

Section 40(2) is an absolute exemption and therefore not subject to the public interest test.

9. Does the trust offer in-hospital way-finding or signage in any language other than English?

I trust this information answers your request. Should you have any further enquiries or queries about this response please do not hesitate to contact me. However, if you are unhappy with the way in which your request has been handled, you have the right to ask for an internal review.
