With reference to your request for information received on 4th January 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

I would like to request a breakdown of how many times have pests been reported on Trust property in 2021/22, 2022/23 and so far in 2023/24? If applicable, please could you provide which pests those were, and in which locations they were found?

I would also like to request how much the Trust spent on pest control in each of the three financial years mentioned.
