Executive Summary					
Amendments to those in the current year, amendments to the Constitution were most					
recently approved in August 2022. As a result of feedback received regarding the need for					
changes to it, specifically in relation to the electoral constituencies and the modernisation					
of voting arrangements, a Governor working group was established in order to examine it in detail and agree proposals to put before the full Council of Governors. The Governors'

The amendments recommended by the Governors' Working Group comprised:

 revisions in relation to the electoral constituencies reflect the working group's feedback about the need for the "Rest of the East Midlands" constituency to be more specifically focussed on the local communities of Mansfield and Ashfield that the Trust serves,

- the modernisation of the voting arrangements, specifically to incorporate the NHSE Model Election Rules that permit electronic voting, thereby enabling future elections to be both more efficient and significantly less expensive as no postage charges will be incurred,
- updates to the paragraphs about terms of office to align them with NHSE requirements that they do not exceed a total of nine years,
- replacing the unused opportunity for the Place Based Partnership (PBP) to nominate a governor, with the opportunity for the new Combined Authority to make a nomination instead. The Mayor has welcomed this opportunity and has confirmed the Combined Authority will work with the Trust to ensure effective participation and representation, and
- taking the opportunity to revise out of date references, for example, to the role of Trust Secretary.

The process for the approval of these amendments has followed the requirements contained in Paragraph 20 of the Constitution. These began with the tracked changes version of the revised Constitution incorporating the proposed changes being presented to the Council of Governors on 13th August 2024. Following their unanimous approval the proposed revisions were recommended to the Trust Board where they were similarly approved at its meeting on 5th September 2024.

As the amendments do not relate to the powers or duties of the Council of Governors there is no formal requirement for a Governor to present them to the Annual Public meeting. However, the Council of Governors recommended that a record of the amendments to the Constitution should be formally placed in the public domain at the Annual Members' meeting to ensure full transparency hence this paper to which the final version of the updated Constitution is attached for information.

The final step in the process, to notify NHSE of the amendments to the Constitution, will be completed after the conclusion of the Annual Members' meeting.

Recommendation: That Trust Members note the agreed changes to the Trust's Constitution effective from their approval by the Trust Board on 5th September 2024.
