1. How many of the organisation's employees have formally identified (on ESR) as a working carer?	87 colleagues have recorded themselves as working carers.			
2. How has the organisation communicated to staff about their rights under Carers Leave Act?	The Trust works with it's Carers Staff Network members twice a year to promote and raise awareness of Carers Rights and the support available to carers in our employment; Carers Week in June and Carers Rights Day in November. Communication of the activities we plan for are supported by our internal communications team.			
3. What training has been given to line managers about the Carers Leave Act?	The Trust provides training for line managers which includes guidance on all leave categories. This training covers Carer's Leave, including the requirements of the Carer's Leave Act.			
4. How many staff have booked Carers Leave for planned events in the last 12 months?	173 staff took leave in the last 12-months that was recorded as carers leave.			
5. What was the average number of days taken?	The average was 1.31 days per episode.
