With reference to your request for information received on 8th March 2024, I can confirm in accordance with Section 1 (1) of the Freedom of Information Act 2000 that we do hold the information you have requested. A response to each part of your request is provided below.

In your request you asked:

Q1. In the past 3 months, how many patients have received the following treatments (for any disease):

- **Berinert (Human C1-esterase inhibitor)**
- **Cinryze (Human C1-esterase inhibitor)**
- **Firazyr (Icatibant)**
- **Icatibant - any brand except Firazyr**

- **Ruconest (Recombinant human C1-esterase inhibitor)**
- **Takhzyro (Lanadelumab)**

We haven't issued any of these drugs in the last 3 months to a patient. Some of these drugs are issued to ward stock and used from there but that information isn't captured anywhere on our stock system.
